

## **Joint Statement on the 40<sup>th</sup> Anniversary of the Establishment of ASEAN-EU Dialogue Relations**

*ASEAN-EU 40<sup>th</sup> Anniversary: Together Towards a Strategic Partnership*

**We**, the Foreign Ministers of the Member States of the Association of Southeast Asian Nations (ASEAN), and the High Representative of the Union for Foreign Affairs and Security Policy / Vice-President of the Commission, gathered on 6 August 2017 in Manila, the Philippines, at the Post Ministerial Conference (PMC) +1 Session with the European Union (EU) to commemorate the 40<sup>th</sup> Anniversary of the Establishment of ASEAN-EU Dialogue Relations;

**Recognising** that 2017 marks the 60<sup>th</sup> anniversary of the Treaties of Rome, the 50<sup>th</sup> anniversary of the establishment of ASEAN and the 40<sup>th</sup> anniversary of the establishment of ASEAN-EU Dialogue Relations; and stressing that over the last four decades, regional integration has made a very positive contribution to peace, stability, security and prosperity in Southeast Asia, Europe and globally and reaffirming the crucial role that regionalism and multilateralism can play in today's world;

**Also recognising** that there is great strength and resilience in the ASEAN-EU partnership as the two organizations combined account for some 18 percent of the world's population and 26 percent of the world's GDP, and recalling that ASEAN and the EU have also made many important contributions to global peace, stability and prosperity, to addressing the challenge of global issues, and to reinforcing multilateralism;

**Emphasizing** the importance of the shared values and common interests that bind the two regions in a long-standing and unique relationship as “partners in integration”, such as the principles of mutual respect for the independence, sovereignty, equality for all states, and including other principles of the United Nations (UN) Charter, international law and the Treaty of Amity (TAC) and Cooperation in Southeast Asia, to which the EU acceded in 2012;

**Reaffirming** the commitment to the 2030 Agenda for Sustainable Development and to promoting and protecting human rights and fundamental freedoms, the rule of law, gender equality and women's empowerment;

**Recalling** the decision of the 20<sup>th</sup> ASEAN-EU Ministerial Meeting in Brussels in 2014 and the 21<sup>st</sup> ASEAN-EU Ministerial Meeting in Bangkok in 2016 for ASEAN and the EU to work towards elevating their partnership to a strategic level;

**ASEAN and the EU hereby:**

1. Celebrate the 40<sup>th</sup> anniversary of ASEAN-EU Dialogue Relations and resolve to accelerate efforts in working towards a strategic partnership between ASEAN and the EU by strengthening cooperation both in traditional areas of dialogue and cooperation including trade, connectivity, development cooperation, energy, research and on political and security issues, as called for in the Bangkok Declaration;
2. Welcome the adoption of the new ASEAN-EU Plan of Action 2018-2022, which covers concrete cooperation programmes in a wide range of fields, as a testament to the breadth and depth of the relations between ASEAN and the EU;
3. Resolve to further enhance political and security dialogue and cooperation between ASEAN and the EU with a view to strengthening regional capabilities in traditional and non-traditional security areas, and in this connection, welcome strengthened dialogue and cooperation on maritime security, counter-terrorism, cyber security, preventive diplomacy and mediation as well as crisis management between ASEAN and the EU;
4. Reiterate their support for ASEAN centrality in the evolving regional architecture in East Asia. The EU appreciates ASEAN's role as the driving force for, and its important contribution to, promoting dialogue, moderation and cooperation for peace, security, stability and prosperity in the Asia-Pacific region and beyond. ASEAN welcomes the interest of the EU in furthering engagement with the region through all ASEAN-led processes. The EU reiterates its support for the *ASEAN Community Vision 2025: Forging Ahead Together* towards a rules-based, people-oriented, people-centred Community;
5. Reaffirm the importance of connectivity and of the economic partnership between ASEAN and the EU with the aim to increasing trade and investment between the two regions and reaffirm their commitment to intensify work towards the resumption of the ASEAN-EU Free Trade Agreement (FTA) negotiations, noting the status of bilateral FTAs between several ASEAN Member States and the EU. They also reaffirm their commitment towards the conclusion of an ambitious and forward-looking region-to-region Comprehensive Air Transport Agreement;
6. Reaffirm their strong commitment to the full and effective implementation of the Paris Agreement under the UN Framework Convention on Climate Change and call on all partners to keep up the momentum created in 2015. They also reaffirm their commitment to the promotion of renewable energy and energy efficiency;

7. Reaffirm the importance of people-to-people contacts and linkages involving, among others, youth, media, academics, think-tank institutions, parliamentary bodies and civil societies; promote cooperation on education as well as encourage mobility of students and academics between ASEAN and the EU higher education institutions; and enhance cooperation in science, technology and innovation;

8. Reaffirm our commitment to regionalism and multilateralism which are mutually reinforcing and which contribute to the peace, security, stability and prosperity of not only the two regions but also the world;

9. Underline the importance of the respect for the rule of law, sovereignty and territorial integrity of States, maritime security and safety, freedom of navigation and overflight, peaceful resolution of disputes, in accordance with the universally recognized principles of international law, including the 1982 United Nations Convention on the Law of the Sea (UNCLOS) and the relevant standards and recommended practices by the International Civil Aviation Organization (ICAO) and the International Maritime Organisation (IMO);

10. Underscore the full and effective implementation of the 2002 Declaration on the Conduct of Parties in the South China Sea (DOC) in its entirety and support the efforts of ASEAN Member States and China to work towards the early conclusion of an effective Code of Conduct in the South China Sea (COC); and

11. Invite the peoples of the two regions to celebrate this important 40<sup>th</sup> Anniversary of ASEAN-EU Dialogue Relations, in order to promote greater understanding and awareness of ASEAN-EU cooperation among the peoples of both regions.
