Hereby Decides

- Article 1: To promulgate the Schedule of the Kingdom of Cambodia for Reduction or Elimination of Import Duties for the period of 2009-2025 under Agreement on ASEAN-India Free Trade Area (AIFTA) as annex to this Prakas.
- Article 2: Import tariff as referred to annex of this Prakas can be applied on the conditions that goods are originating pursuant to Rules of Origin and Operational Certification Procedures Provisions.
- Article 3: Importers shall abide by regulations of General Department of Customs and Excise of Cambodia.
- Article 4: This Prakas shall come into force 30 days after signing.
